PRIVACY POLICY

Thank you for using **BoBe.app** ("**BoBe**," "**we**," "**us**," or "**our**"). BoBe is a DeFi application that provides algorithmic trading functionality, a utility token ("BoBe Token"), a Baking mechanism, and related services (collectively, the "**Services**"). This Privacy Policy explains how we collect, use, disclose, store, and protect information obtained from users ("**User**" or "**you**") in connection with your interaction with BoBe.

By accessing or using BoBe's Services, you confirm that you have read and understood this Privacy Policy. If you do not agree with any part of this Policy, please discontinue use of the Services immediately.

1. SCOPE

1.1. Applicability

This Privacy Policy applies to the personal or non-personal information we collect through BoBe's website (<u>https://bobe.app</u>) and any other related channels where BoBe's Services are offered.

1.2. Relation to Terms of Use

This Privacy Policy should be read together with our <u>User Agreement</u> (or as otherwise published). In case of a conflict, the Terms of Use will prevail with respect to the Services.

1.3. Third-Party Services

Our Services may integrate with or contain links to third-party protocols, wallets, or applications beyond our control. This Privacy Policy does **not** cover third-party platforms or blockchains. We encourage you to review the privacy policies of any external service you use in connection with BoBe.

2. DATA WE MAY COLLECT

2.1. Minimal Personal Data

BoBe is a DeFi application, designed to operate with minimal collection of personal information. In general, you are not required to submit personal data (such as your name, address, or government-issued ID) to interact with our smart contracts.

2.2. Technical Information

When you visit <u>https://bobe.app</u> or use our Services, we may collect limited technical information automatically:

- **IP Address** (anonymized/pseudonymized when feasible)
- Device and Browser Information (type, version, OS)
- Usage Data (pages visited, features used, timestamps)
- Cookies or Similar Technologies (session and/or preference cookies)

2.3. Wallet and Transaction Data

- If you choose to connect a cryptocurrency wallet to interact with BoBe's Services (e.g., for Baking, utility token usage, or algorithmic trades), your **public blockchain address** is visible to us and may appear in usage logs.
- We do **not** collect your private keys or custody your crypto assets.

2.4. Optional Contact Information

• If you voluntarily contact us (e.g., via support@bobe.app), we may collect and store your email address, messages, and any additional information you provide to address your inquiry or feedback.

3. HOW WE USE THE COLLECTED DATA

3.1. Service Functionality

We use on-chain data (e.g., your public address) and basic technical logs to facilitate the DeFi operations offered by BoBe (e.g., Baking, algorithmic tools, token-based functionalities), provide user interfaces, and secure your session.

3.2. Analytics and Improvement

We may analyze aggregated or anonymized usage data to:

- Understand performance and user flow
- Identify potential improvements
- Maintain or enhance user experience

3.3. User Support

If you contact us (e.g., email support), we use the information you provide to respond to your requests and improve our Services.

3.4. Security Measures and Fraud Prevention

Limited technical logs (IP addresses, device info) may be used to detect suspicious activities, bot traffic, or malicious behavior, in order to protect BoBe's users and infrastructure.

4. SHARING AND DISCLOSURE OF DATA

4.1. No Sale of Personal Data

We do **not** sell or rent your personal data to third parties.

4.2. Service Providers

We may share limited data (e.g., server logs, aggregated analytics) with trusted third parties for hosting, security, or analytics. These providers only receive the information necessary to perform their roles and must handle it securely and confidentially.

4.3. Legal Compliance

We may disclose data if required by law, regulation, court order, or to protect our or others' rights and safety. Where possible and legally permitted, we will give you notice of such disclosure.

4.4. Corporate Changes

In the event of a merger, acquisition, or reorganization of our project or related assets, data may be transferred to successors or affiliates in accordance with applicable laws and this Privacy Policy.

5. DATA RETENTION

5.1. Duration

We retain technical logs or on-chain references for only as long as necessary to fulfill the purposes described in this Policy, or as required by law. Since blockchains are public ledgers, transaction data is inherently permanent and outside our direct control.

5.2. User-Initiated Deletion

- If you contact us by email, we may retain your messages as needed to provide customer support or comply with legal requirements.
- For on-chain data, we cannot alter or remove blockchain records.

6. YOUR RIGHTS

Depending on your jurisdiction, you may have rights regarding your personal data, such as:

- Access: Request if and how we process your data.
- Rectification: Update or correct inaccuracies in the data you provided.
- Erasure: Request deletion of certain stored personal data if permitted by law.
- **Restriction/Objection**: In some cases, request a temporary or permanent halt to certain processing or object to specific uses.

Note: We cannot erase or modify blockchain data. Additionally, certain basic logs (IP addresses, usage metrics) may be necessary to maintain security and compliance.

7. COOKIES AND SIMILAR TECHNOLOGIES

7.1. Cookie Usage

We may use session or persistent cookies on https://bobe.app to:

- Remember your preferences (e.g., language, interface layout)
- Enable analytics to improve user experience
- Enhance security features

7.2. Managing Cookies

You can control or delete cookies through your browser settings. Disabling cookies may affect non-essential features but should not prevent you from using critical DeFi functionalities.

8. SECURITY MEASURES

8.1. Technical Safeguards

We employ industry-standard security measures, such as encryption (HTTPS/TLS) and server access controls, to protect the limited data we handle off-chain.

8.2. User Responsibility

As a DeFi platform, **you** remain responsible for the security of your crypto wallets, private keys, and seed phrases. BoBe does **not** have access to or custody over your private keys.

8.3. Incident Handling

Should we become aware of any security breach that compromises personal data under our control, we will notify affected users or regulators as required by applicable law.

9. THIRD-PARTY LINKS AND EMBEDDED CONTENT

The BoBe platform may contain links to third-party resources or embedded widgets (e.g., analytics dashboards, wallet connectors). This Policy does **not** govern data practices of third parties. We recommend reviewing their respective privacy policies independently.

10. CHILDREN'S PRIVACY

BoBe's Services are not directed to minors under the age of majority in their respective jurisdictions. We do not knowingly collect personal data from children. If you believe we have inadvertently collected such information, please contact us at **support@bobe.app**, and we will investigate and take prompt action.

11. INTERNATIONAL DATA TRANSFERS

The internet is global, and so is blockchain technology. By using BoBe, you acknowledge that data (including on-chain data) may be processed and stored on servers located outside your country of residence. We strive to use service providers that follow recognized security standards, but we cannot control the inherent public nature of decentralized ledgers.

12. POLICY UPDATES

We reserve the right to modify or update this Privacy Policy at any time to reflect changes in our practices or relevant laws. When we do, we will revise the "Effective Date" at the top. Your continued use of BoBe following any updates indicates acceptance of the revised Policy.
